Madam, Sir,

Following consultation with your Office in its capacity as receiving Office, International Searching Authority (ISA), International Preliminary Examining Authority (IPEA) or designated and/or elected Office under the Patent Cooperation Treaty (PCT), and with certain intergovernmental and non-governmental organizations and certain other users of PCT data by means of Circular C.PCT 961, the Director General has decided on certain modifications of the format of the front page of the PCT pamphlet, the *PCT Gazette* in electronic form and the *PCT Gazette* in paper form.

The modifications are as proposed by Circular C.PCT 961 (dated December 4, 2003). Additional modifications were made as a result of the consultation procedure and these are explained in detail in Annex I.

The modifications to the front page of the PCT pamphlet, which will apply *mutatis mutandis* to the presentation of each entry in the *PCT Gazette* in electronic form, are set out in Annex II; the additional modifications to the introductory pages and Sections I and II of the *PCT Gazette* in paper form are set out in Annex III. All modifications are identified by vertical lines in the margins of the sheets concerned.

Entry into force of the modifications

The International Bureau will start employing the new format of the front page of the PCT pamphlet and the *PCT Gazette* as soon as the first international application is published with an international filing date on or after January 1, 2004.

Annex I to Circular C.PCT 986

DETAILED EXPLANATIONS OF THE ADDITIONAL MODIFICATIONS

Front page of the PCT pamphlet

The first additional modification concerns the designation of the African Regional Industrial Property Organization (ARIPO) and the African Intellectual Property Organization (OAPI) in Internationally agreed Numbers for the Identification of (bibliographic) Data (INID) Code (84). Under the amended Regulations under the PCT, as in force from January 1, 2004, a State is automatically designated for every kind of protection available and since both regional organizations provide for more than only patent protection, the reference to "ARIPO patent" and "OAPI patent" would not reflect the new designation system.

The second additional modification concerns the designation of a State where this has been withdrawn for a certain type of protection only but not the designation of that State for all types of protection; the added indication in parentheses next to the two-letter code of the designated State as for which type of protection that particular State continues to be designated is modified to only include the indication of the remaining (not withdrawn) type of protection (for example, "DE (*utility model*)" where the designation of Germany for the purpose of a patent has been withdrawn). For technical reasons, in the case of multiple remaining types of protection, the two letter code of the designated State would be repeated for every remaining type of protection (for example "BR (*patent*), BR (*utility model*)").

Introductory pages to weekly issues of the PCT Gazette and Section I of the PCT Gazette

The further modifications to the introductory pages of the *PCT Gazette* in paper form provide for a definition of INID Codes (81) and (84) both for international applications filed before and on or after January 1, 2004. This is necessary since, at least for a certain amount of time, Section I of the *PCT Gazette* in paper form will have to provide for the indication of international applications filed before January 1, 2004 as well as on or after that date.
