### ESTABLISHMENT OF NEW EQUIVALENT AMOUNTS OF THE SEARCH FEE CHARGED BY THE EUROPEAN PATENT OFFICE (EPO)

- 1. This Circular is addressed to your Office in its capacity as receiving Office (RO) under the Patent Cooperation Treaty (PCT) for the purposes of consultation on proposed new equivalent amounts of the search fee charged by the European Patent Office (EPO).
- 2. According to PCT Rule 16.1 (a), the European Patent Office has established a new amount of its search fee in Euro (EUR) as follows:

### EUR 1,785

- 3. This new amount will be applicable as from April 1, 2010.
- 4. In accordance with PCT Rule 16.1(b) and (c), new equivalent amounts of that fee as set out in bold in the table attached to this Circular will be established.

5. It is to be noted that, and according to the agreements between the International Bureau and Swedish Patent and Trademark Office and Nordic Patent Institute, both acting as International Searching Authority, there is also a similar change in the amount of the search fee for these 2 Offices. Consequently, new equivalent amounts of their respective search fee have also been included in the table referred to above and will be applicable as from April 1, 2010.

- 6. Concerning the amount of the search fee for an international search performed by the Spanish Patent and Trademark Office and the National Board of Patents and Registration of Finland, the International Bureau is in the process of confirming whether their respective search fee will also be changed in the same way and from the same date. If so, the same equivalent amounts will apply. A confirmation will be sent later.
- 7. If your Office does *not* agree with the proposed (rounded) equivalent amounts shown in bold in the tables, please contact my colleague Mrs. Agnès Grocq, Senior Administrative Assistant, PCT Operations Division (tel.
