# ESTABLISHMENT OF NEW EQUIVALENT AMOUNTS

This Circular is addressed to your Office in its capacity as Receiving Office under the Patent Cooperation Treaty (PCT) for the purposes of consultation regarding a new equivalent amount of your international filing fee.

The exchange rate between the Swiss franc (CHF) and the Canadian dollar (CAD) has been, for more than 30 consecutive days, more than 5 percent lower than the exchange rate used for establishing the present equivalent amount.

In accordance with the directives adopted by the PCT Assembly at its thirty-second session (September 22 to October 1, 2003), new equivalent amounts in CAD will be established with effect from July 1, 2010, as follows:
