Madam, Sir,

I have the pleasure to invite your Office, in its capacity as an International Searching Authority under the Patent Cooperation Treaty (PCT), to a meeting of the PCT Minimum Documentation Task Force, to be hosted by the European Patent Office (EPO) on Tuesday, May 21 (9 a.m.) and Wednesday, May 22, 2019. The working language for this meeting will be English.

This meeting follows a suggestion from the EPO at the twenty-sixth session of the Meeting of International Authorities under the PCT (PCT/MIA), held in Cairo on February 13 and 14, 2019, to convene a physical meeting among experts. The EPO had made this suggestion noting that the outstanding details in Objectives B and C of the Task Force were complex and finalizing them through the electronic forum may be slow and difficult (see paragraph 75 of the Summary by the Chair of the session, document PCT/MIA/26/13).

The draft agenda, prepared by the EPO as Task Force leader, is available on the PCT Minimum Documentation Task Force wiki discussion forum. The agenda focuses on detailed criteria and standards required to ensure that prior art can be loaded onto databases and searched effectively. The EPO would therefore welcome participation at the meeting from patent information experts able to deal with such technical topics, and hopes that the discussions could lead to the Task Force submitting detailed proposals to the PCT/MIA in early 2020 (see document PCT/MIA/26/8). The agenda also includes discussions on Objective D on non-patent literature and traditional knowledge-based prior art, where it is hoped to make significant progress during the meeting. Other meeting documents will also be made available on the Task Force wiki discussion forum.
