- ² In accordance with the Basic Law of the Macao Special Administrative Region of the People's Republic of China (PRC), the Government of the PRC decides that the Treaty shall apply to the Macao Special Administrative Region. The declaration took effect on November 6, 2013.
- ³ Applicable to the Faroe Islands as of April 30, 2018.
- ⁴ The accession by New Zealand shall extend to Tokelau.
- ⁵ Serbia is the continuing State from Serbia and Montenegro as from June 3, 2006.
- ⁶ The United Kingdom extended the application of the Treaty to the territories of the Bailiwick of Guernsey and the Isle of Man with effect from January 1, 2021.
