Thank you for your design application, number 208227 (UK Design number 6090867) filed on 14^{th} February 2020.

Your application has failed to meet the requirements of the Registered Design Act 1949 for the following reasons:

Disclosure of Design

Your application discloses more than one design and therefore does not comply with Section 1(2) of the Act, as outlined above. A UK application can consist of a number of visual elements including colours, lines, contours etc. As soon as differences in appearance occur, the design to be protected changes.

The illustrations filed show both greyscale (1.1-1.25) and coloured (1.26-1.30) images within the same application.

Such illustrations as those provided show inconsistency in colour and therefore result in ambiguity in the disclosure of the design in question. As the appearance of the design has not been sufficiently disclosed, your application is not acceptable in the UK.

Overcoming the above objection

The application can be overcome if you limit the reproductions to either those which show no colour (1.1-1.25) or those which include colour (1.26-1.30)

Address for Service

You are required to provide an address for service (correspondence address) within the EEA for the purposes of any proceedings under the UK Registered Designs Act 1949.
